- 2. Barry Ford significant other of the recently dismissed employee. Confirmed that she cared greatly about the families and the community. I have been with her thorough this journey I have seen this women come early, stay late and empower coworkers because she has put children first.
- 3. Anthony Higgins speaking about concern the continued loss of colleagues and the reputation fourth year untenured employee –relatively new employee concerns were disconcerting public hearing position on speaking what does it say about our community and what is relevant nervous to speak in front of the board, not easily intimidated. In his estimation, they have lost James Lassiter his calm and steady behavior 25% new student's middle school needs to have a huge administrator. The reason why he had to leave was never given this has raised questions in their community. The losses are not normal. The accelerated program of the middle school it's a possible fail by the board. Quote by Thurgood Marshall to separate children. I say this with conviction that the students have raised issues with the division of the accelerated program and being separated. I got this job by happenstance, I loved working here. The school had a great reputation. My time here I have seen a massive loss of staff. It's up to the board to determine the future of the school. At the June board meeting I will be resigning.
- 4. James Laster I am here to back up other things that have already been discussed. I have been contacted by 8 employees for letters of recommendation. The reason why they want to leave is the lack of comfort and the feeling that leadership and administration is not backing them up and a culture of fear has been implemented. To leave on the circumstances that I did was awful. The staff feels like when you step up or speak up there will be consequences. This is a pit stop for staff. I don't think that you want that. The incentive for these educators is no longer there. I just want to bring this to your attention. I left due to the treatment by Colin Hogan.
- 5. Nicole Kinnety I just want to be clear that in defense of the accelerated track. Perhaps the schedule change. The accelerated track is creating racial segregation and it is very upsetting. The children are very aware.

- 6. Shelley Skinner commented about the achievement gap and a conversation of 10 years. They are committed to working on. It might not be great enough for everyone but that has been the thing we focus on the most.
- 7. Bertram Okpokwasili Board Member questioned accelerated learning.
- 8. Marty Macorty ghosting no communication to the staff about a staff members leave A child wrote the situation that happened and posted it on the staff member's door. I didn't even know who the new Athletic Director was. Better communication needs to be implemented.
